

The Seneca Falls Town Board held a Year-End Meeting on Tuesday, December 27, 2022 in the Town Hall Meeting Room, 130 Ovid Street, Seneca Falls.

Present were Supervisor Michael Ferrara; Councilpersons Kaitlyn Laskoski, Frank Sinicropi and Steven Churchill. Also present was Peter Soscia, Town Manager.

Supervisor Ferrara called the Meeting to order at 12:00 Noon. A roll call of Board Members was taken and Councilwoman Dyson was absent from the Meeting; the Pledge of Allegiance followed.

New Business:

SFPD Resolution: A motion was made by Kaitlyn Laskoski and seconded by Frank Sinicropi to adopt the following resolution:

WHEREAS, the Glock 30 Gen4, Serial number WRH119 will be purchased by the Seneca Falls Police Benevolent Association, Law Enforcement Officers Union, Council 82, Local 3614 for \$300.00.

NOW, THEREFORE, BE IT RESOLVED, the Seneca Falls Police Benevolent Association, Law Enforcement Officers

Union, Council 82, Local 3614 will transfer the Glock 30 Gen4 Serial number WRH119 to a Federal Firearms Licensed Dealer; and be it

FURTHER RESOLVED, the Federal Firearms Licensed Dealer will transfer the Glock 30 Gen4 Serial number WRH119 to retired Police Chief Stuart W. Peenstra.

A motion was made to amend the above motion to not charge the Seneca Falls Police Benevolent Association, Law Enforcement Officers Union, Council 82, Local 3614 \$300.00 for the Glock 30 Gen4 Serial number WRH119, but to gift it to the Seneca Falls Police Benevolent Association, Law Enforcement Officers Union, Council 82, Local 3614, by Michael Ferrara and seconded by Kaitlyn Laskoski. 
